The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected

1. **Basic Services of Funeral Director, Staff and Overhead \$ 2,338.00**

- This fee represents a proportional share of our operating costs necessary to provide our customers with the best facilities and services that we can offer. It is made up of two components: services of our funeral directors and staff and, basic overhead.
- Our services include:
 - Conducting the arrangement conference;
 - Planning the funeral;
 - Consulting with family and clergy;
 - Sheltering of remains;
 - Obtaining necessary permits and authorizations;
 - Coordinating with the cemetery, crematory or other third parties
- Our overhead includes:
 - Proportionate share of operating costs including, but not limited to:
 - Taxes;
 - Licenses;
 - Utilities;
 - Fee;
 - Insurance;
 - Staff Salaries.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.

2. Standard Embalming	\$395.00
Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

11. Forwarding of Remains to Another Funeral Home **\$1,912.00**
 This charge includes: a proportionate amount of our overhead costs, embalming, initial transport of deceased from place of death to our funeral home; if relevant, receptacle for the body, and air tray. This charge does not include director, staff, or facilities for visitation and/or rites prior to forwarding the body or transportation cost to nearest airport.

12. Receiving of Remains from Another Funeral Home **\$1,550.00**
 This charge includes: a proportionate amount of our overhead costs, care of the deceased and local transportation of the deceased to the cemetery or crematory. This charge does not include services of staff or use of facilities for viewing, visitation, rites or ceremonies or transportation from nearest airport.

Receiving Cremated Remains from Another Funeral Home **\$255.00**
 This included temporary shelter of cremated remains, transportation to local cemetery and necessary services of the director and staff for burial, does not include any type of service at cemetery, merchandise or any cash advances.

13. Immediate Burial without rites or services **\$2,375.00**
 Our Charge for Immediate Burial includes: a proportionate amount of our overhead costs, initial transfer of the deceased from place of death to the funeral home and local transportation of the deceased to the cemetery. **This price does not include casket selected. Does not include cemetery charges or outer enclosure if required by cemetery.**

- 1. Immediate burial with container provided by the purchaser **\$2,375.00**
- 2. Immediate burial with minimum casket (Rough Cut Pine) **\$2,600.00**
- FOR A SCHEDULED GRAVESIDE SERVICE ADD** **525.00**

14. Direct Cremation without rites or services **\$2,290.00**
 Our charge for direct cremation includes: Initial transfer of the deceased from the place of death, a proportionate amount of our overhead costs, other preparation of the body, and transportation to the crematory in South Burlington. **This price does not include a cremation container or casket selected or any cash advances. (Crematory Fee - \$450.00 and Medical Examiners Fee and permit - \$30.00 are not included)** The cremated body will be returned to you in a **temporary** container.

If you want to arrange for direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are constructed of corrugated cardboard.

15. Body Donation to a Medical School or Facility \$ 1119.00

Our charge for assisting in University of Vermont College of Medicine Anatomical Gift Program (**Without Ceremony**) includes: Basic services of Staff, a proportionate amount of our overhead costs, initial transfer of deceased from place of death and transfer to UVM College of Medicine.

Coordination Fee\$255.00

This includes arrangement of a service at a Church of other facility and/or interment of cremated remains at a cemetery of your choice. This fee does not include the presence of Funeral Director or staff at the service or burial.

16. Our Basic Service charge includes a \$6.00 fee that will be sent to the State of Vermont and set aside for the protection of holders of contracts for prepaid funeral arrangements.

17. Funds may be available for final disposition through the Vermont Department of Social Welfare, General Assistance Program, for those who qualify. You may contact them by calling 802 863-7365.

19. Estates

In some cases the deceased's estate must pay for funeral expenses. Since processing of estates may require many months and we are not able to extend financing, we request that a responsible person take the financial obligation for the expenses and then file for reimbursement from the estate.
